<u>DEVELOPER/ BUILDER</u>	Boone Homes, Inc. of Roanoke
<u>DIRECTIONS</u>	From Route 419 go South on 221. Right on Rosecrest after Cave Spring Baptist Church. Left on Roselawn Road approximately 1 mile to entrance to Stone Manor.
<u>MODEL</u>	Unfurnished Model will change as each sells. Homes used as Models are not for sale.
<u>LOCKBOXES</u>	On Model and all homes for sale, as needed.
<u>FLOOR PLANS/ ELEVATIONS</u>	All lots, plans, and elevations available on all houses offered for sale. Call New Homes Manager at 278-1369, if you need a plan.
<u>CONTRACTS/ RESTRICTION</u>	Preprinted contracts and POA packets at Long & Foster South Office. Disclosure IS required and Acknowledgment of Receipt of P.O.A. Package must accompany a contract in order for the contract to be presented.
<u>DEPOSIT</u>	\$5,000 deposit payable to Boone Homes, Inc. of Roanoke for homes started on speculation. A 10% deposit, payable to Boone Homes, Inc. of Roanoke, is required for Build Jobs. No notes accepted. **ALL OPTIONS MUST BE PAID FOR AT CONTRACT SIGNING, AS AN ADDITIONAL DEPOSIT AMOUNT OVER AND ABOVE SELLER'S STANDARD DEPOSIT AMOUNT FOR BOTH HOMES BUILT ON SPECULATION AND BUILD JOBS. When lot premiums apply, the lot premium is included in the purchase price of the home (speculation or Build Jobs) and does not have to be added in full to the amount of the deposit.
<u>CLOSING COSTS</u>	Buyer pays all closing costs.
<u>LOAN APPL.</u>	All loan applications must be made within five business days of contract.
<u>TAXES</u>	\$1.13/\$100 – evaluation at 100%.
<u>HOMEOWNER'S</u>	\$100.00 initial contribution at closing. Thereafter, \$135.00 on January 15 of each year following. Fees cover maintenance of entrance shrubbery, walls and lighting.
